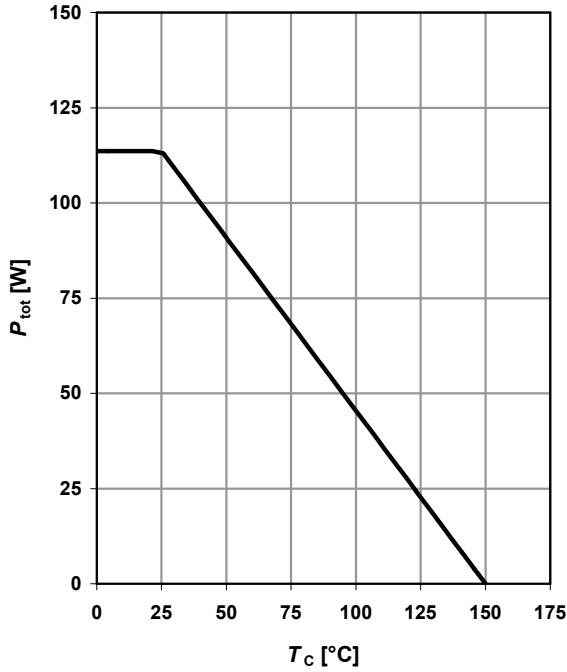

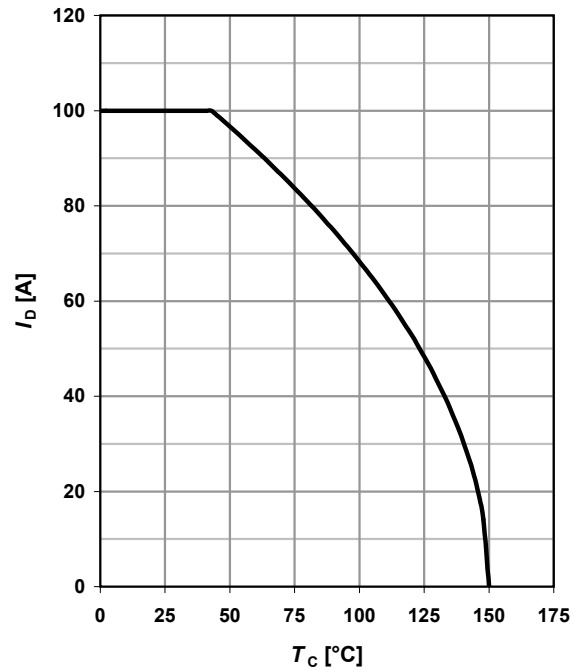

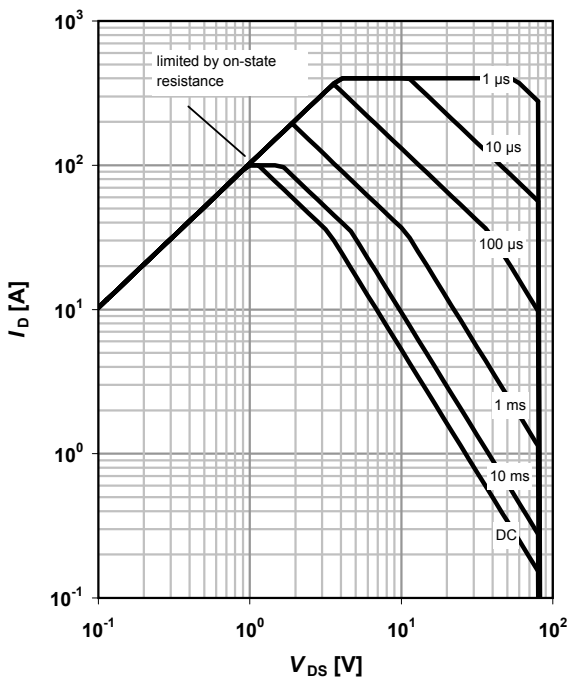

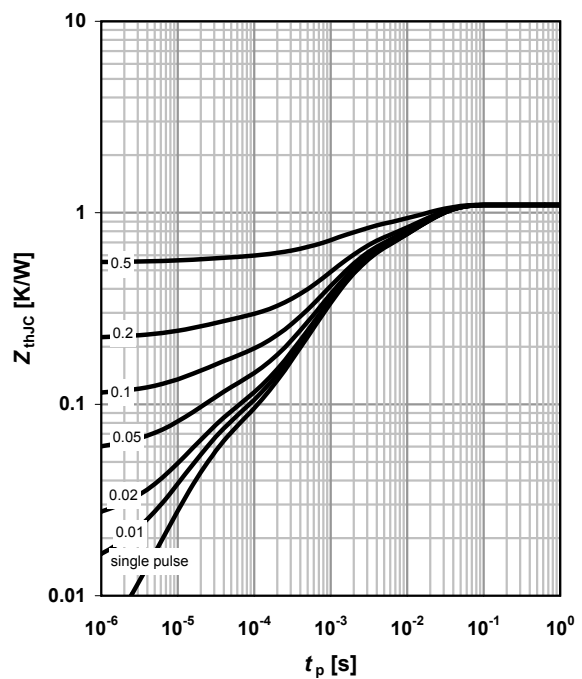

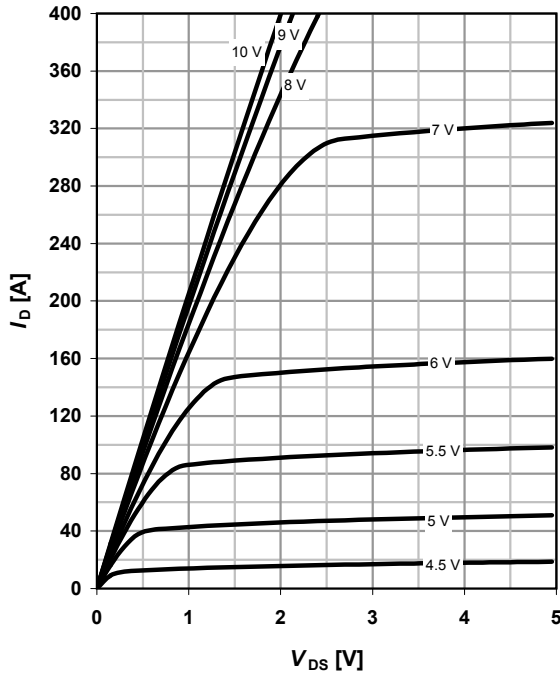

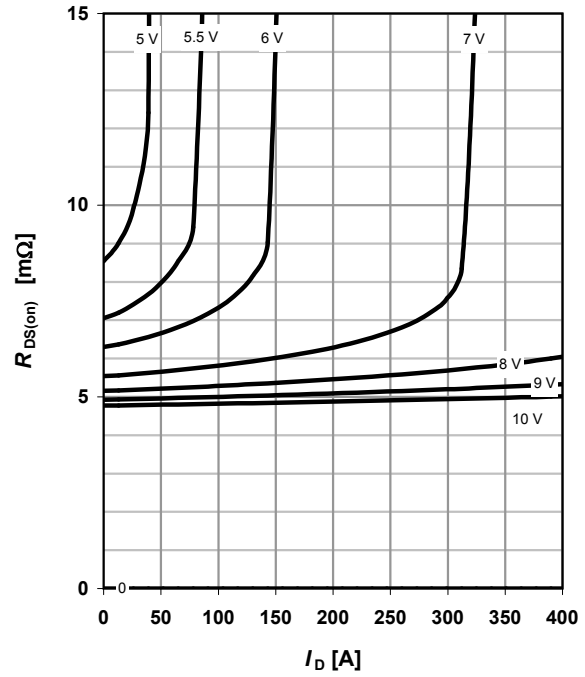

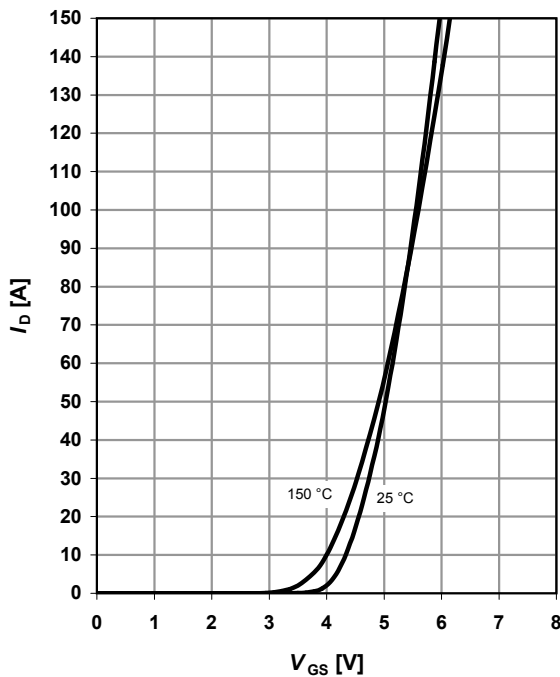

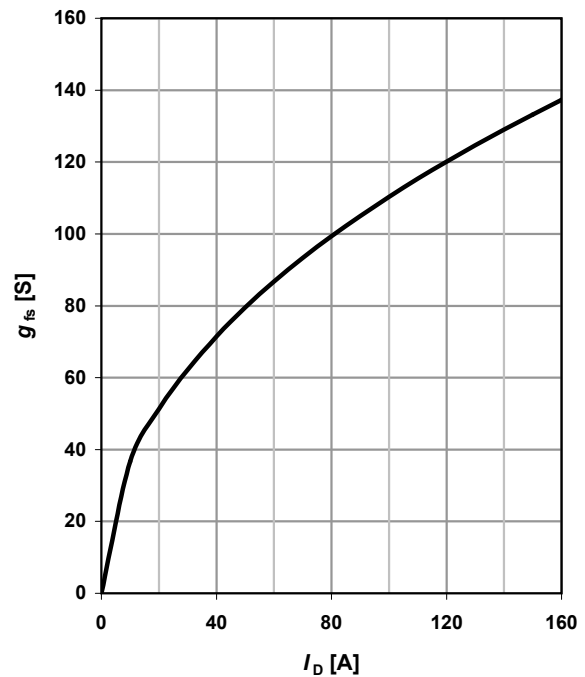

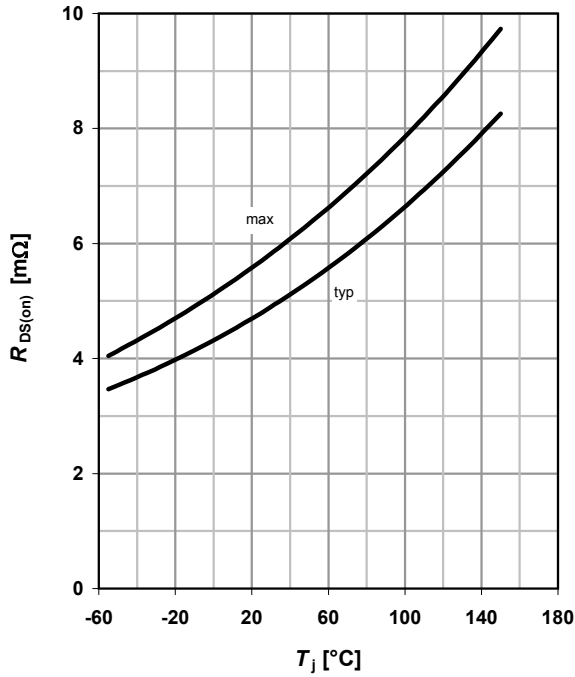
8 Typ. forward transconductance

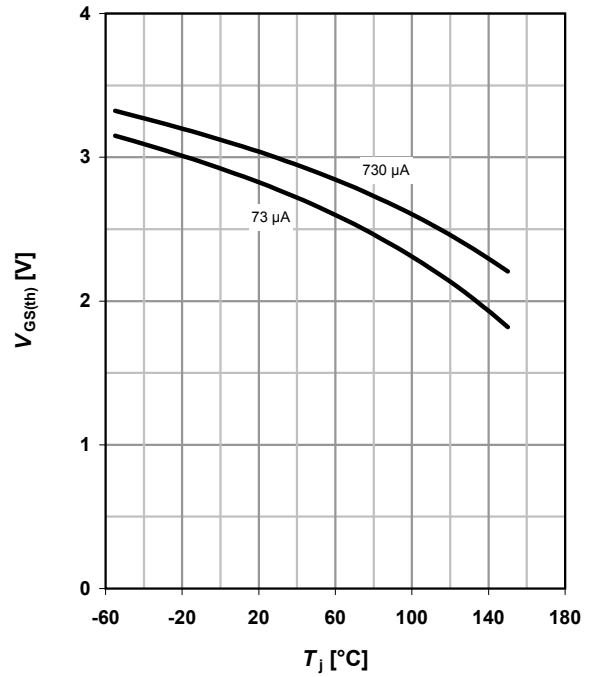

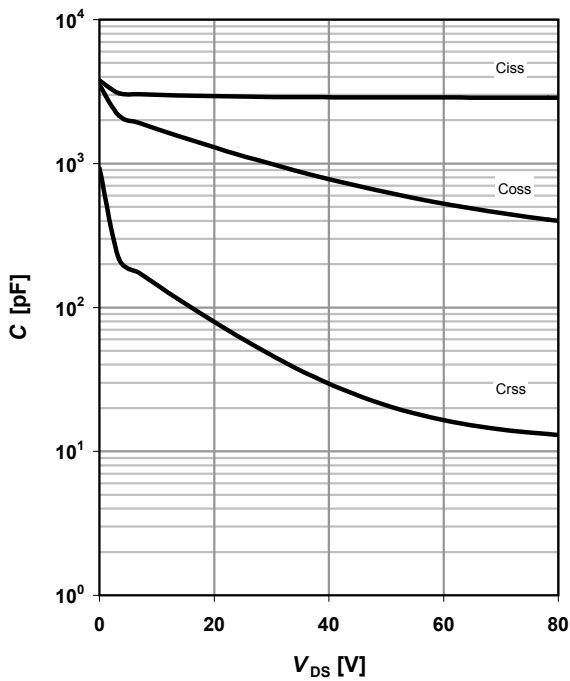

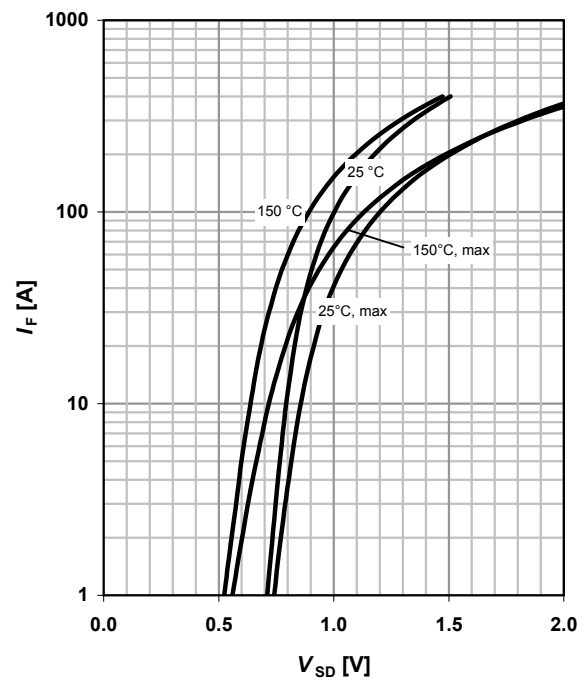

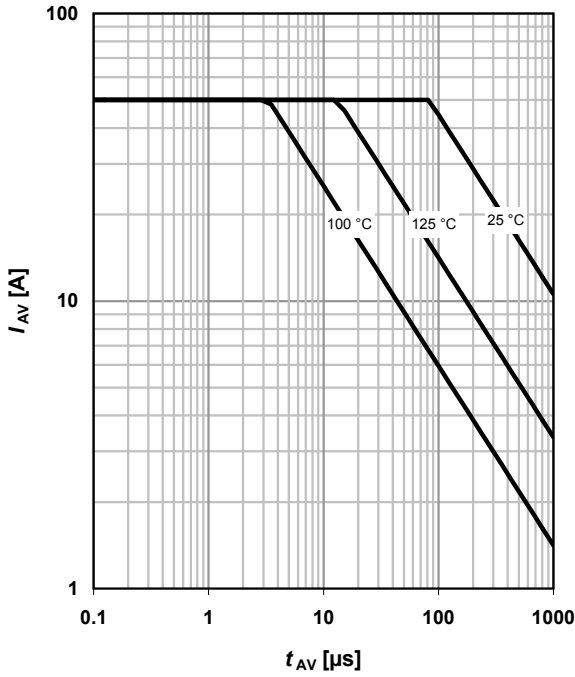

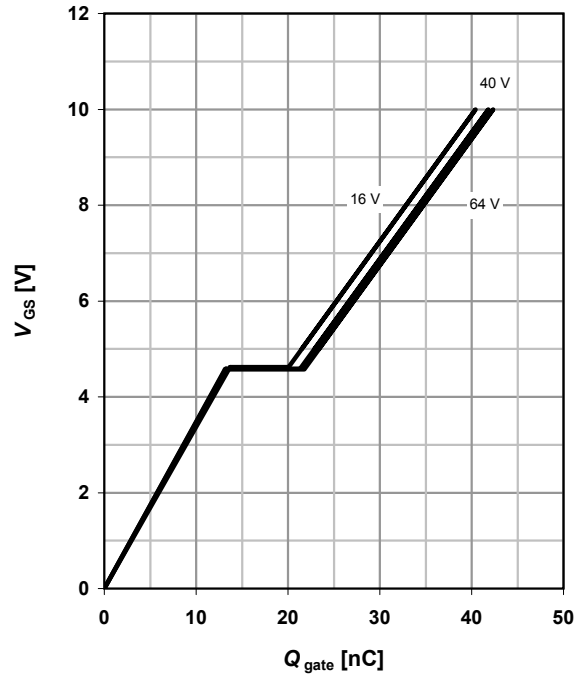

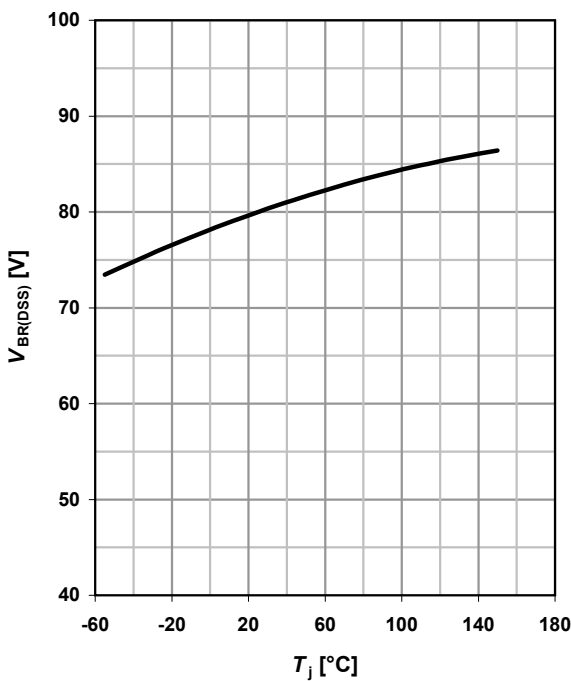

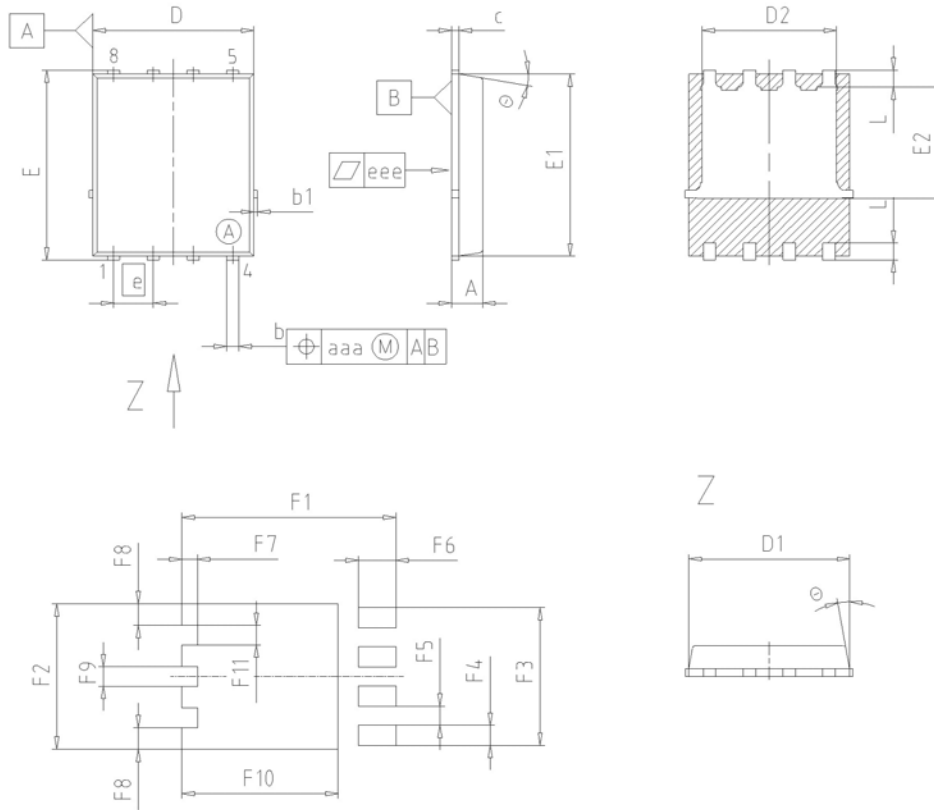
