1.1 General description

NPN silicon germanium microwave transistor for high speed, low noise applications in a plastic, 4-pin dual-emitter SOT343F package.

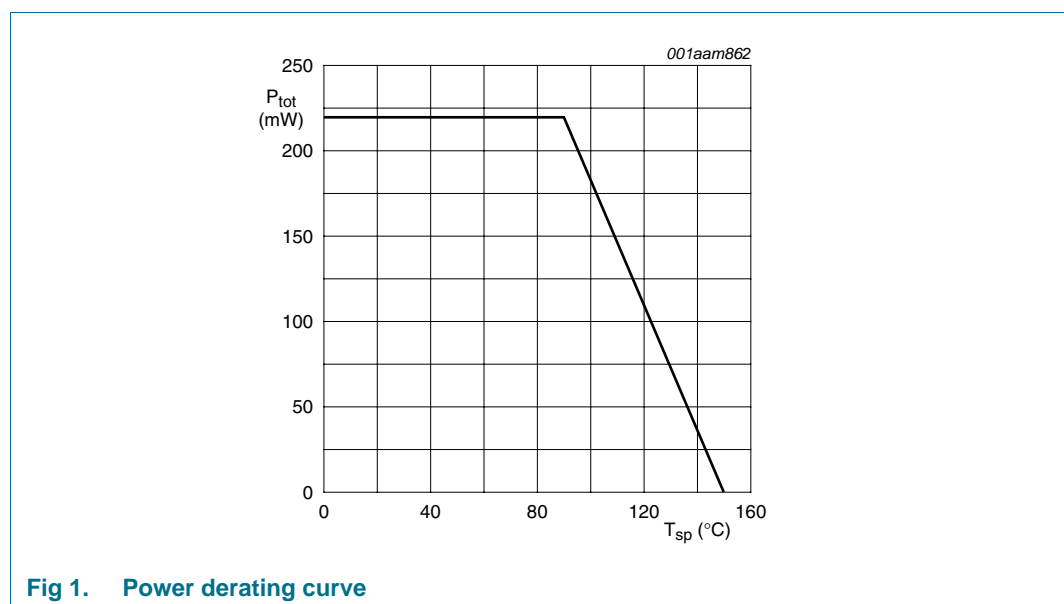


Fig 1. Power derating curve

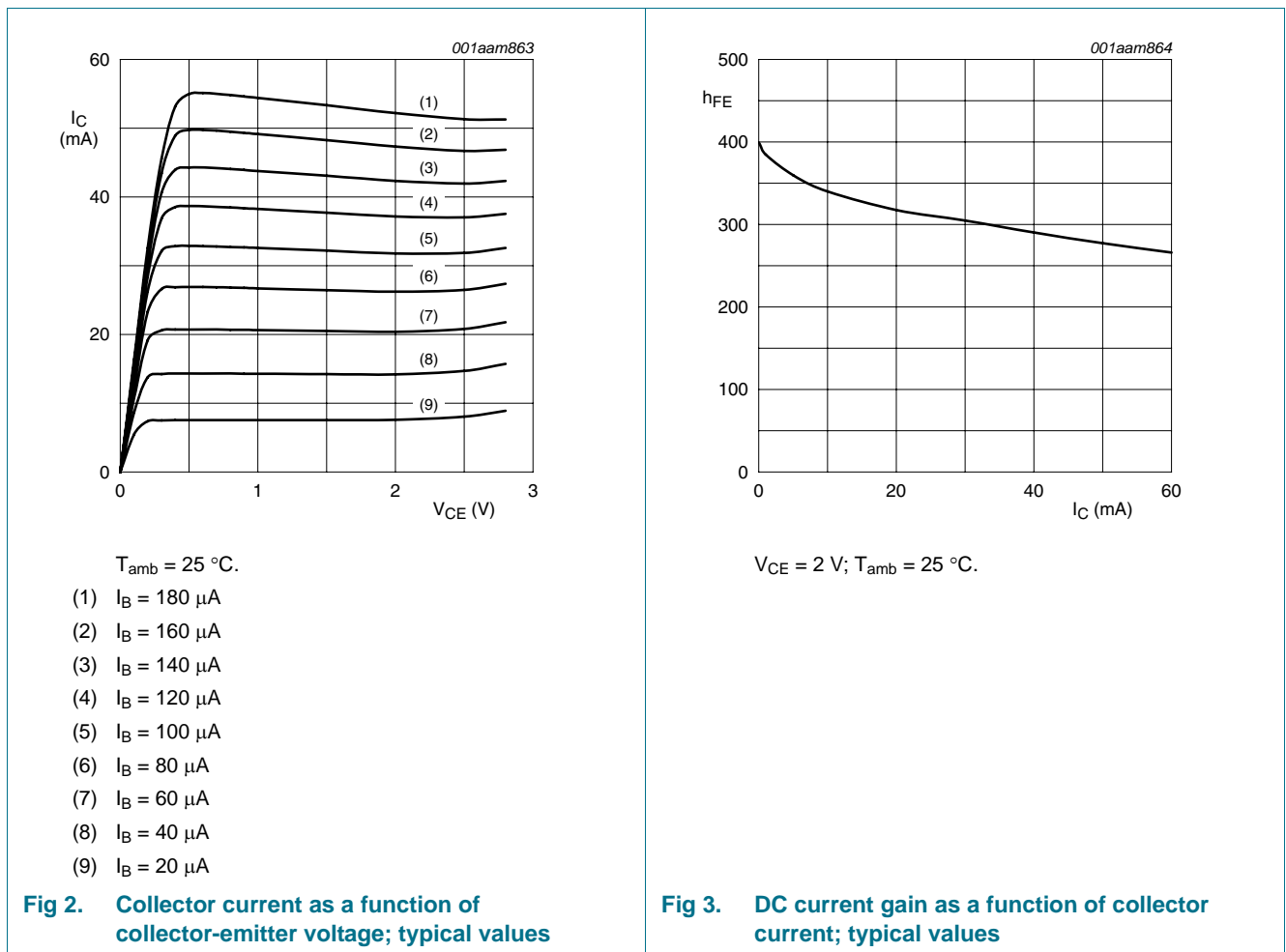

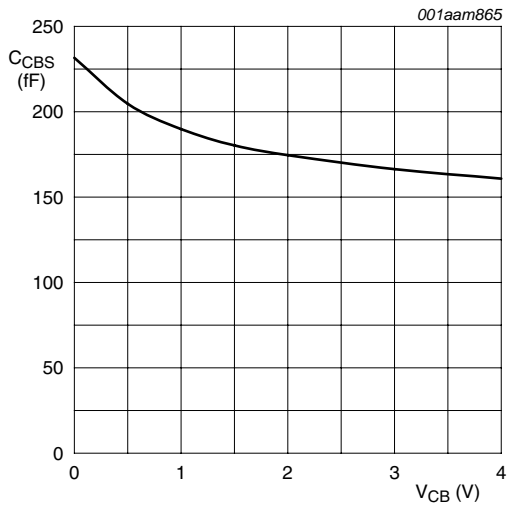

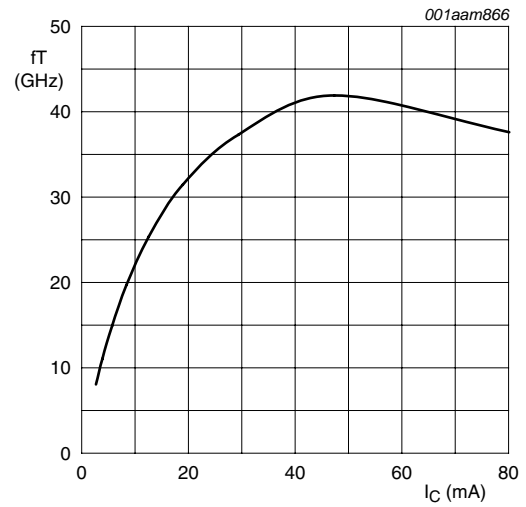

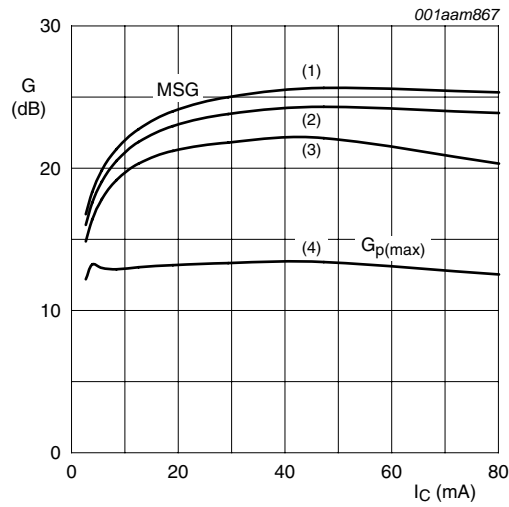

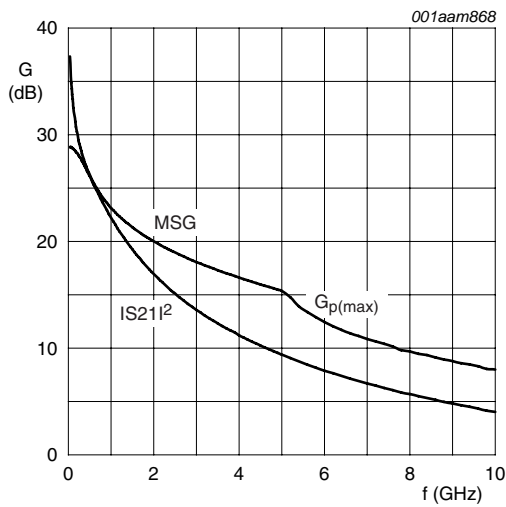
Fig 5. Transition frequency as a function of collector current; typical values



$V_{CE} = 1 \text{ V}$; $T_{amb} = 25 \text{ }^\circ\text{C}$.

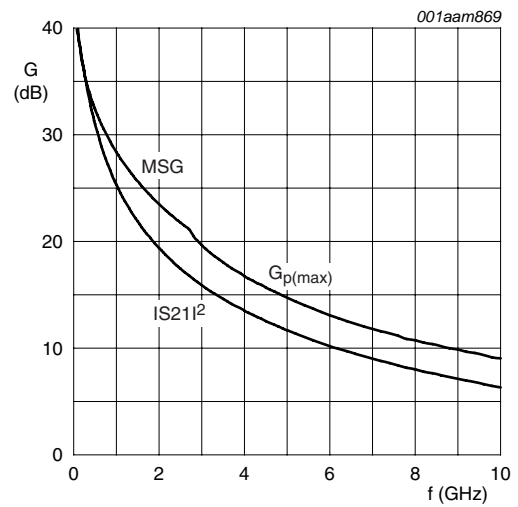

Fig 6. Gain as a function of collector current; typical value



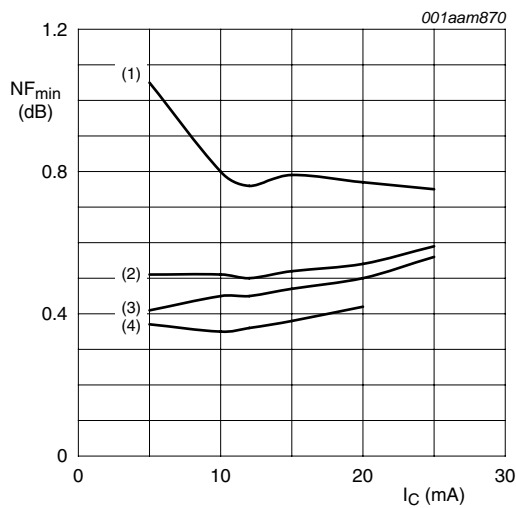

$V_{CE} = 1\text{ V}$; $I_C = 50\text{ mA}$; $T_{amb} = 25\text{ °C}$.

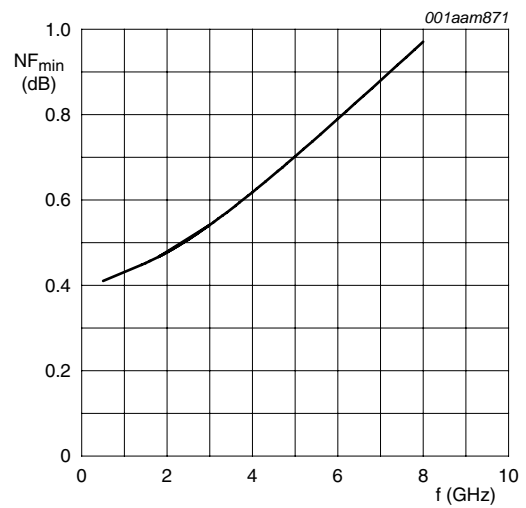
Fig 8. Gain as a function of frequency; typical values

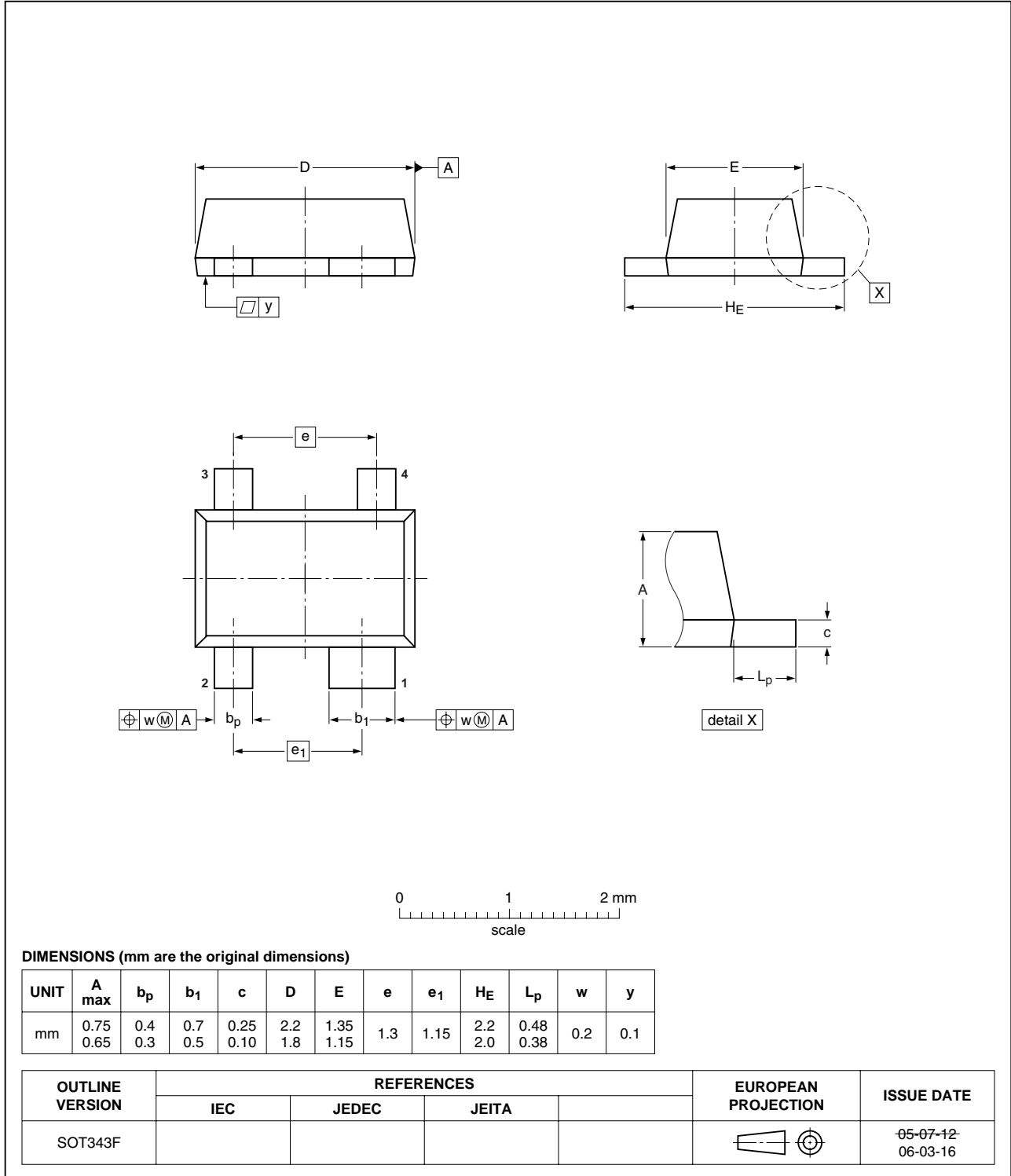


Fig 11. Package outline SOT343F
